The rebate is applicable exclusively during the eligible promotional window and necessitates online or mail-in submission in accordance with the terms and conditions set forth herein.

ELIGIBILITY CRITERIA

New Customers Only: This Promotion is available solely to first-time Qualifying Building Company(s) who have not previously made a purchase of our products during the eligible rebate period from TimberHP (hereinafter referred to as the "Company"). Purchases made by homeowners or individuals on behalf of Qualifying Building Company or Trade Professional cannot be accepted. ****Rebate redemption is not eligible to Homeowners or Individuals****

Eligible Products: Only the specific TimberBatt™ products enumerated on the promotional page are eligible for the rebate (minimum purchase of 1 full pallet of TimberBatt™ is required for eligibility): TimberBatt™ Thermal - Wood Stud, all products (excluding 7.25" R30)
